FOLLOWING TERMS AND POLICIES:**

- You are over the age of 21, as well as guests.
- Payment is due upon signing and is nonrefundable and is nontransferable. Partial month will be prorated, with the start date as of the first of next month.
- Monthly term membership dues will automatically be processed the first day of each month for a 12-month period via on file credit card.
- You can store cigars purchased from The People’s Cigar Republic LLC and any other products as long as they do not violate any Federal, State, or local laws.
- You assume full responsibility for the contents of your locker. The People’s Cigar Republic LLC does not insure nor is it responsible for any contents stored in the lockers.
- You will be issued a lock for your locker, and it must be returned upon termination of membership. There will be a \$20 charge if lock is lost.
- The People’s Cigar Republic has the right to access any locker at any time necessary or by law.
- Management reserves the right to close the lounge on occasion for any purpose or function.
- Management reserves the right to open the lounge to the public for any purpose or function.
- Management reserves the right to suspend or revoke membership for non-payment of bill, breach of contract, misconduct, or failure to adhere to any of the rules, regulations, and policies set forth by The People’s Cigar Republic, LLC.
- The People’s Cigar Republic LLC reserves the right to suspend access to any locker for 30 days due to non-payment. If non-payment exceeds 60 days, The People’s Cigar Republic reserves the right to seize contents of locker and terminate membership.
- The People’s Cigar Republic reserves the right to refuse service and/or lounge access to any person.
- Business-related documentation should be handled and displayed correctly. Quiet discussions and the use of papers and laptop devices with sound muted. Cellular phones may only be used in a manner that does not disturb other members or their guests. Texting is permitted with the sound muted. The display of merchandise or business products and solicitation of said products or services by members and/or guests is not permitted. The Club’s name is not permitted for contact information on members’ personal or business-related correspondence or other materials.

### **PRIVATE HUMIDIFIER LOCKERS**

- Members are not permitted to install their own lock on a locker.
- Lockers cannot be used to store items that may violate any Federal, State, or Local Laws.

- Management reserves the right to access any locker for the purpose of maintenance and inspection.
- Upon termination of membership, all locker contents must be removed within 24 hours or items shall be deemed abandoned and will be disposed of in any manner the Club elects.
- A fee of \$20.00 must be paid for the lock. If the lock is lost and a new one is needed, the same amount will be charged. Lock deposit will be returned upon termination of membership.

Members with permission to conduct a business meeting may request permission to bring appetizers to attendees. Members are permitted to bring alcoholic beverages to the club for personal consumption. Member acknowledges that the ability to consume alcohol in the Club is a privilege and members of his guests will consume such alcohol in a responsible manner. Alcohol may be stored in Full member's lockers.

- No membership contact information may be shared with others without written consent of the member (s).
- Boisterous or indecent conduct will not be tolerated in the Club. Members are encouraged to report such conduct to management.
- Members should leave the Club in the same condition as it was found upon arrival as a courtesy to others.
- Damage to the club furniture and fixtures because of the Member's carelessness or disregard shall be corrected at the member's expense.
- The Club reserves the right, in its sole and absolute discretion, to alter, amend, rescind, and add to those rules and regulations. Membership will be notified of such changes.
- The member shall hold the Club harmless from any and all liability in the event the member's action led to some criminal or other legal liability.
- If legal action must be taken by the Club against any member and the Member is found to be liable then the member shall be liable for any damages assessed by the Court as well as any and all reasonable attorney's fees.
